


Is this Your First Baby? (n=20 patients)









Little Remedies Advanced Colic Relief and Gas Relief Patient Trial Program

Abstract

Colic and gas are frequent problems, with the average pediatrician participating in the trial recommending treatment to about 12 patients with colic and/or gas each month. In this program, 504 pediatricians reported on 965 patients receiving a full-size Little Remedies® Advanced Colic Relief Drops sample and/or a full-size Little Remedies® Gas Relief Drops sample.

Safety with no side effects, a formulation without alcohol, high fructose corn syrup, artificial flavors and colors and the unique blend of chamomile, fennel and lemon balm, topped the reasons for recommending Little Remedies® Advanced Colic Relief Drops. Also compelling were data reported in the Journal of Pediatrics (Weizman 1993) that showed mixtures of chamomile, fennel and lemon balm decreased crying in colicky infants, and positive clinical experience with any or all of the ingredients.

The most common rationale for recommending Little Remedies® Gas Relief Drops was that parents and doctors prefer products without alcohol, saccharin, and preservatives and simethicone safety. Interestingly, 61% of patients reported on by prescribers, received both products primarily because of safety, while almost half of physicians reported that these conditions often present concomitantly.

Twenty parents responded to the patient feedback survey, with 4 using just the Little Remedies® Advanced Colic Relief Drops, 3 using just the Little Remedies® Gas Relief Drops and 13 patients, 65%, using both. All respondents rated the importance of a product with no alcohol, high fructose corn syrup, saccharin, preservatives and artificial colors and flavors as "most important"; rating this feature a "5" on a scale from 1-5.

80% of parents reported that the Little Remedies® product(s) that they used relieved their baby's symptoms while 20% reported that the product(s) relieved symptoms "somewhat". Importantly, 100% of patients got some relief. Overall patient satisfaction across products was 4.6 on a scale of 5.

These data support use of Little Remedies® Advanced Colic Relief Drops for symptoms of colic and Little Remedies® Gas Relief Drops for symptoms of gas. For clinicians and parents looking for a safe and effective intervention, use of these Little Remedies® products, offer such an option.

589 patients got both products 724 colic relief (135 just colic) 830 gas relief (241 just gas)







Formulation and Safety Topped the Reasons HCPs selected Little Remedies® Gas Relief Drops




